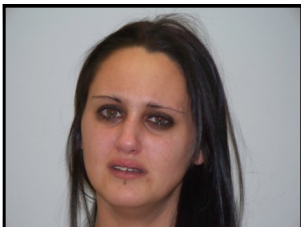

Illegal Possession of Firearms

Officer Cronin and Trp. Hanafin conducted a MVST on Rte. 28 near Hiramard Rd. on 12/7 at 1320hrs. for erratic operation. The operator was Juliann Kusy, 23 of Hyannis and the passenger was Christopher Newell, 21 also of Hyannis. Kusy was belligerent and disorderly during the stop and was placed under arrest. Newell did not have a drivers license which resulted in the vehicle being towed. An inventory of the vehicle revealed the glove box to be locked. Investigators towed the vehicle to BPD and obtained a search warrant for the locked compartment. There, they found two loaded firearms, cash, and drug packaging supplies. During the search of the vehicle it was learned that Newell (who had been released from the scene of the stop) was now in a MV located in a parking lot behind the police station. It's believed that Newell was going to attempt to enter the BPD compound and retrieve the items in the glove box. Newell was placed under arrest and charged with being an armed career criminal, illegal possession of a firearm, illegal possession of a high capacity firearm and conspiracy to violate narcotics laws. Kusy was charged with disorderly conduct, operating to endanger, speeding, failure to use care in turning, illegal possession of a firearm, illegal possession of a high capacity firearm and conspiracy.
